Relevant Experience

Jennifer possesses a deep practical and theoretical understanding of corporate governance. During her time at Board Matters she has led the following successful advisory briefs:

- A governance review with the Australian Dental Association (ADA) throughout 2023. We worked closely with the ADA Federal Council and CEO to uplift the governance structures through various key stakeholder consultations and presentations. We then offered the 16,000 strong membership a modernised governance and legal structure as well as a new constitution. This review was successful at the ADA AGM held late last month and was the most significant governance change for the ADA in the last 50 years. This engagement's success relied heavily on our expertise and experience and we were thrilled to see this acknowledged in the (then) President's LinkedIn post [here](#).
- Throughout 2021-2022, we assisted Cattle Council Australia transition its structure, supporting the \$10B grass-fed cattle industry, from a federated structure strongly governed and influenced by State Farming Organisations (SFOs) to a new entity (Cattle Australia). The newly developed structure feature a skills-based board, individual levy payers could vote and have influence within their peak cattle industry body, whilst maintaining the expertise of the SFOs with some influence and advisory capabilities.
- Board Matters was engaged by RSL (Queensland Branch) to modernise its constitution from an outdated document that was decades old to one which was closer to representing modern good governance practice. This involved a year-long campaign with stakeholder engagement covering over 130 Sub-Branched, which culminated in a special general meeting where the new constitution, drafted by Board Matters, was passed. This is the one and only time in the last decade that a significant constitutional change for RSL (Queensland) was passed by the voting members at the first general meeting at which the members had the opportunity to vote.
